Lady Crown And On Behalf of Ngati Rangihou Corrangie Hapu dba Office of the Crown gives notice that the proceeding involves a matter arising under the Constitution or involving its interpretation within the meaning of section 78B of the Judiciary Act 1903.

Nature of Constitutional matter

Treaty, Constitutional, Jurisdictional and Corporations Act 2001 (not in force) Issues.

Facts showing that section 78B Judiciary Act 1903 applies

1. The creditor is a child of Io Matua Yahuwah, God, Papatuanuku, Ranganui, Ngati IO, Ngati Kupe Nuku, Nga Puhi-Moana-Ariki, Ngati Rahiri, Ngati Manu, Ngati Tautahi, Ngati Rehia, Ngati Hine, Ngati Hau, The House of Mecklenburg via Treaty adoption to Ghungalu, Bidjara, Kullilli, Biria, Manandangie, Kungari, Githabul Ngarakbul Tribal Nations of the Original current Land mass known as Australia & New Zealand.
2. The creditor is primarily bound by the Laws of the Original Tribal Nations mentioned in Clause 1. This involves serious matters of Treaty, Constitutional and Jurisdictional issues within but not limited to the sole and exclusive Jurisdiction of the High Court of Australia. The aforesaid Treaty, Constitutional, Corporation Act 2001 and Jurisdictional issue falls under but not limited to the terms of the Commonwealth of Australia Constitution Act 1900 and the High Court of Australia is the only valid court available but not limited to at law to hear this Application.

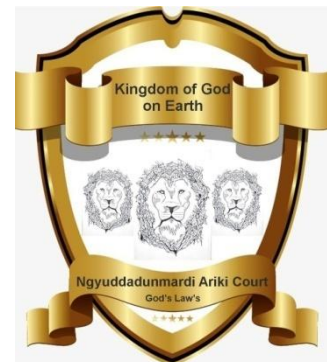

3. The Creditor requires to clear these issues by way of this Section 78B notice under the Judiciary Act 1903 as it is a matter that affects the entire Original Tribal Nations of Australia.
4. The Creditor is fully aware that the Corporations Act 2001 C2017C00128 states '**It is in Force**' however, as stated in the Proclamation (12/07/2001) C2004L06605 it is '**No Longer in Force**'. Therefore the Corporations Act 2001 C2017C00128 is not currently in force leaving the Federal Court Naked.
5. The Creditor is fully aware that the COMMONWEALTH OF AUSTRALIA CIK#: 0000805157 is register at the Business Address 1601 Massachusetts Ave NW, C/O Australian Embassy Washington DC 20036. SIC 8880.
6. Unless a valid Corporations Act can be produced with consent of the First Laws in Time, as all other laws are foreign to the Australia land mass, The Creditor requires to clear these issues by way of this Section 78B notice under the Judiciary Act 1903 and with the Sealed Final Orders dated 20th September 2019.
7. The issues herein are important for all Attorneys General of the States, Territories and Commonwealth of Australia, including New Zealand (a state of Australia as stated in the Commonwealth of Australia Constitution Act 1900 19th July 1900) to determine and are of paramount importance to the [Ab]original people and all other citizens of Australia & New Zealand.
8. The previous filed Notice of Constitution Matter dated 30th August 2019 is no longer relevant or active. This Notice of Constitution Matter dated 22nd September 2019 is now standing in its place.

THE NGYUDDADUNMARDI ARIKI TRIBAL COURT ORDERS THAT:

- 1) Pursuant to the God's Laws, First Laws in Time & He Whakaputanga o te Rangatiratanga o Nu Tireni 1835 [Declaration of Independence 1835], Letter from Queen Victoria 1858 the fact that Corporations Law 459G (Not in Force), and the fact that New Zealand is defined as a state of Australia (never repealed), i herein order as

the Sovereign Queen Lady Crown Turikatuku III and Judge that the following be reinstated, ordered and adhered to *effective immediately*;

ARTICLE 1. We declare that the independence of our country, which is hereby constituted and declared to be an independent state, under the designation of "The United Tribes of Aotearoha".

ARTICLE 2 All sovereign power and authority within the state of "The United Tribes of Aotearoha" is hereby declared to reside entirely and exclusively in the hereditary Chiefs and heads of the tribes in our collective capacity, who also declare that we will not permit any legislative authority separate from ourselves in their collective capacity to exist, nor any function of Government to be exercised within the said territories , unless by persons [public servants] appointed by us, and acting under the authority of laws & lores regularly enacted by us in congress assembled.

ARTICLE 3 The hereditary Guardian of Divinity, Arikinui, Chiefs and heads of the Tribes, Mobs & Clans agree to meet in congress at Waitangi (Aotearoha Embassy) & Rangihou (Australian Embassy) in the Autumn of each year for the preservation of peace and good order, and the regulation of exchange, and we cordially invite the Tribes, Mob's & Clans to lay aside their private animosities and to consult the safety and welfare of our common countries by joining "The Kingdom of God on Earth [Te Whare Matamuatanga O IO] .

ARTICLE 4 Letters Patent 8th August 2016, Paremata Rangihou Sovereign Nation & Embassy & The Governance of Love & Guardians of Divinity & The Royal Charter. Letters Patent 1st July 2019, Kingdom of God on Earth & The Governance of Love & Guardians of Divinity & The Royal Charter.

- 2) Pursuant to the Commonwealth of Australia Constitution Act 1900 19th July 1900, and the fact that New Zealand is defined as a state of Australia (never repealed), we order that the Beehive, The Settlers Government of New Zealand [Government & Parliament of New Zealand Company], be removed from our lands of Aotearoha which is commonly known as the land mass New Zealand, *effective immediately*.
- 3) Pursuant to the God's Laws, First Laws in Time & Corporations Law 459G (Not in Force) the Parramatta City Council ABN 49 907 174 773 including all derivatives of, associated entities, business names, trading names are to be wound up and liquidated *effective immediately*, pursuant to the Originating Application Sections a, b, c, d, e, f, g & h.
- 4) Creditor herein reduces the Statutory Demand dated 1st April 2019 to Two Hundred and Eight Million to be in Solid Gold Coins or Paid from the Public Trust and

Parramatta City Council in commonwealth dollars (UK) to Lady Crown, the Paramount Arikinui of Paremata, of the Office of the Crown *effective immediately*: Bank Account Name: Tino Rangatiratanga Foundation, BSB 633000 ACC: 161850599.

- 5) Creditor herein orders that all profits made from Rangihou & Baludarri Lands since 8th May 2019 to be deposited in Solid Gold Coins or Paid in commonwealth dollars (UK) to the Office of the Crown, Bank Account Name: Tino Rangatiratanga Foundation, BSB 633000 ACC: 161850599 *effective immediately*, overnight.

- 6) Creditor herein order that the following Sacred Lands be returned *effective immediately*. Lands that are in the hands of the Parramatta City Council, NZ & Australian Government, which is illegitimate property that was acquired by force and injury to others, therefore genocide & crimes against humanity was enacted. Lands, Crown Lands and buildings being as follows;
 - (a) Rangihou Lands being 112 Acres (Aotearoha Embassy) - From Parramatta River, up Morton Street, left onto Victoria Road, left onto Wilde Avenue and back to the Parramatta River boundaries, to be returned *effective immediately* to Sovereign Queen Lady Crown Turikatuku III via the Tino Rangatiratanga Foundation; and
 - (b) Baludarri Lands from the Parramatta River, up Morton Street, right onto Thomas Street, right onto James Ruse Drive back to the Parramatta River boundaries; and
 - (c) Rangihou Crown Land - James Ruse Reserve, 109 Harris St, 115 Harris St, 137,143,145,147 George Street, The Waterways Between Rangihou Reserve And Queens Wharf Reserve, Queens Wharf Reserve, Robin Thomas Reserve; and
 - (d) 116 Macquarie Street Parramatta - Corner of Charles St and Macquarie St; and
 - (e) Deakin Park in Silverwater - Corner of Beaconsfield St and Silverwater Road; and
 - (f) Callan Park in Rozelle - Parramatta River, up Wharf Road, Military Road, Central Ave, Waterfront Drive To Parramatta River - Including Mauri Ratana Rock Carvings On The Rocks; and
 - (g) Rodd Island; and
 - (h) Ihumatao Lands in Auckland, Aotearoha (commonly known as New Zealand) to be returned *effective immediately* to Pania Newton via the Tino Rangatiratanga Foundation; and

- (i) Waitangi Lands (Embassy) in Auckland, Aotearoha (commonly known as New Zealand) to be returned *effective immediately* to Sovereign Queen Lady Crown Turikatuku III via the Tino Rangatiratanga Foundation.
- 7) Creditor herein orders the Judge and the Prime Minister to make a Public Announcement to Australian News Networks within 24hrs of these orders being served, that they have been relieved of their fiduciary duties as Trustees and as the Local Council authorities. That the Office of the Crown, with Royal Prerogative Authority, God's Law's and the First Laws in Time, will be the upstanding Administrators. That Sovereign Queen Lady Crown Turikatuku III, the True Crown will be the Paramount Arikinui of Paremata Rangihou Sovereign Nation & Embassy & Aotearoha.

BILL OF COSTS

- 8) Creditor herein orders that the Outstanding Bill of costs as stated on affidavit dated 9th July 2019 to be paid effective immediately by Mr Alexander White and/or Defendant and/or Sparke Helmore Lawyers. Deposited into the Office of the Crown, Bank Account Name: Tino Rangatiratanga Foundation, BSB 633000 ACC: 161850599 effective immediately, overnight.
- 9) Creditor herein orders that the Outstanding Invoice as stated in Asseveration dated 30th August 2019 to be paid effective immediately by Mr Alexander White and/or Defendant and/or Sparke Helmore Lawyers. Deposited into the Office of the Crown, Bank Account Name: Tino Rangatiratanga Foundation, BSB 633000 ACC: 161850599 effective immediately, overnight.
- 10) Creditor herein orders that the Outstanding Invoices (twenty six invoices @ \$42 Million each) emailed to Judge Jacqueline Gleeson on 19th September 2019 for Misprision of Treason to be paid *effective immediately*, deposited into the Office of the Crown, Bank Account Name: Tino Rangatiratanga Foundation, BSB 633000 ACC: 161850599 effective immediately, overnight. If no payment is not received, the Office of the Crown orders that charges be brought against each wrongdoer as per the Misprison of

Treason orders 12th September 2019.

- 11) Creditor herein orders that any Bill of Costs presented by the Defendant, be dismissed effective immediately.

ANY OUTSTANDING ISSUES

- 12) Creditor herein removes all outstanding issues, Interlocutory orders and bills of cost from the list of cases awaiting finalisation in the Federal Court of Australia.
- 13) Creditor orders that no amendment be made to the Originating Process to reflect any other entities.
- 14) Creditor orders that any future breaches against the Creditor will invoke the Claim of Right, Terms & Conditions, Fee Schedule, Copyright Agreement, Trademark User Agreement and Crimes Act 1900, 1914 & 1958.

AUTHORITY

- 15) For and on the Record, The Office of the Crown's authority to Act comes from God under the protection of the **Kingdom of God on Earth &**
 - (a) God's Law's (Laws of the Land); and
 - (b) First Loes in Time, First in Line, Best in Law; and
 - (c) Common Law; and
 - (d) Grandmother Skin Loes; and
 - (e) International Protectorate, Laws on the Sea - United Tribes Flag 1835; and
 - (f) Queens Letter to Maori 1858; and
 - (g) Sovereign Nations Treaty for the Protection of Rangihou and Baludarri Sacred Burial Sites and Lands; and
 - (h) Letters Patent 8th August 2016 – Paremata Rangihou Sovereign Nation & Embassy; and
 - (i) Letters Patent 1st July 2019 – The Kingdom of God on Earth & Governance of Love & Guardians of Divinity & The Royal Charter; and
 - (j) He Whakaputanga o te Rangatiratanga o Nui Tireni 1835; and
 - (k) Te Tiriti o Waitangi 1840; and

- (l) And this here The Ngyuddadunmardi Ariki Tribal Court & Federal Court of Australia Final Order dated 6th September 2019.
- 16) The Ngyuddadunmardi Ariki Tribal Court agreed that leave be granted for the defendant/wrongdoer to seek intervention and or remedy in the International Court of Justice and the United Nations Human Rights Commission, if they deem necessary.
 - 17) The Ngyuddadunmardi Ariki Tribal Court instruct that due to the fact that the Corporations Act 2001 is Not In Force, Final Orders now stand in law, unrebutted, accepted by equitable estoppels by acquiescence.
 - 18) The Ngyuddadunmardi Ariki Tribal Court orders a Sheriff, the Police and a Liquidator to enforce the Final Orders.
 - 19) The Ngyuddadunmardi Ariki Tribal Court orders full disclosure of Brett Newman, Robert Lang, Greg Dyer, Mark Stapleton, Rik Hart, Sue Coleman, Sue Weatherley, Debbie Killian, Scott Greig, Simon Officer, Brad Delapierre, Andrew Wilson, John Chedid, Scott Lloyd, Viv May, Merv Ismay, Mark Brisby, Amanda Chadwick, Maarama Kamira, Phil Littlewood, Kerwin Meldrum, Andy Giannotis, Noel Doan, Chris Drury, Timothy Castle & Alexander White - Full Name (Birth Certificate), Current Residing Address, Date of Birth, Tax file Number Documents to be emailed to participant999@protonmail.com.
 - 20) The Ngyuddadunmardi Ariki Tribal Court orders full disclosure of Trusts, Deeds, Stocks, Property Portfolio, Insurance Policies & Underwriter Policy Documents to be emailed to participant999@protonmail.com.
 - 21) The Ngyuddadunmardi Ariki Tribal Court orders that a full tax audit be undertaken immediately.
 - 22) The Ngyuddadunmardi Ariki Tribal Court instruct that a copy of the Court minutes from 6th September 2019 be attached to the Final Orders.
