### Perjury & Misprision of Treason Committed by Parramatta City Council 9th October 2019 Matter of: NSD711/2019

We refer to proceedings NSD711/2019 which are listed for Judgment before her Honour Justice Gleeson on Monday, 14 October 2019.

1. We write to you with the upmost of love and respect for who *You* are: *Your* highest authority: *Your* sovereignty in *Your* dominion: and for what *You* are capable of, as the respected Judge that you are. *You* are respected and for this reason, we write to *You* in your private chambers.
2. We do detest wickedness: the ongoing abuse of the courts: and law conspiracy, the inappropriate behaviour by the defendants, through correspondence from Tim Castle, Sparke Helmore Lawyers, which was sent via email, to our Office of the Crown dated 9th October 2019 at 2.30pm. This email of deceit is seeking our consent on a number of subjects with demands. For this reason, No one who practices deceit shall dwell in *Our* house; no one who utters lies shall continue before *Our* eyes. No consent is given to a lying tongue or a flattering mouth worketh ruin.
3. Parramatta City Council continues to openly commit perjury and misprision of treason by abusing us with their unlawful and illegal entity, being the 'CITY OF PARRAMATTA'. Their tongue devises destruction like a sharpened razor: Workers of deceit, arrogantly switching hats, status and identities, in a blatant attempt to pervert the course of justice, yet again and again. If a director must hearken to lies, all his servants are wicked. Only a foolish man builds his house upon sand and water.



4. Judge Gleeson, we ask that you vindicate us and plead our case against an ungodly company; deliver us from deceitful and unjust men who stand on uneven ground manipulating words, laws and the court system.
5. We recognise that *You* are enlightened and virtuous as *We* are. We see you: and call on you to '*stand with us*' in truth on this holy matter. The blood of Jesus and the river of life runs through us all, in every minute of every day. Teach us *Your* way, Judge Gleeson: and lead us on a level path, because of our oppressors (Psalm 27:11). Lift us up from the pit of destruction, out of the miry clay; set our feet upon a rock, and make our footsteps firm (Psalm 40:2). We will proclaim *Your* name to all our brothers and sisters of this nation; We will praise You in the assembly (Psalm 22:22).

6. *You are one with Us, We are one with You. From a Judge to a Judge we all stand with the highest of laws and authority. God's Law's, First in Time, First in Line, Best in Law.*

***Please stand with us!***

7. We are asking you to respect who *We* are in Our highest divine right and authority: in Our sovereignty: in Our dominion: and in what *We* are capable of as the True Crown & Tribal Judges that *We* are: And the owners and guardians of these lands: with undisputed rights to the soil which is true and unrebuted in law. Even if we testify about Ourselves, Our testimony is valid, Our testimony is true, because *We* know where *We* came from and where *We* are going. But you do not know where *We* came from or where *We* are going.

*"The mouth of the righteous woman utters wisdom, and her tongue speaks justice. For she speaks the truth and detests every kind of deception." Lady Crown – Lady of Justice.*

8. We are not an enemy of the state. *We* are *Your* allies: *Your* friend: *Your* family: And Brothers and Sisters if you choose to live in peace with us. We are not combative but gentle and considerate, not quarrelsome but forbearing and peaceable. We don't hate anyone. We love you and that's why *We* are bringing these serious matters to your attention. We love everything God created and God created *You*. We will forgive the sins of your forefathers and love & care for your offspring in perpetuity or eternal life, should you stand with us. You will be a Judge in the highest places in the Kingdom of God, standing firmly in solidarity with the First Nations Peoples. This we can promise you.

***Come stand with us!***

9. We have attended to our administrative processes efficiently. We have sent the '*Notice of a Constitutional Matter under s78B Judiciary Act 1903*' via email, on the 10th & 25th of September 2019 to Alexander.White@sparke.com.au. We demolish arguments and every pretension that sets itself up against the knowledge of God, and we take captive every thought to make it obedient to our Lord.
10. You may recall Judge Gleeson, the young man, Solicitor Alexander White who lied about his company identity, pointing to *The Local Government City of Parramatta and Cumberland Proclamation 2016* for salvation, who drowned in the murky waters of deceit. Judgment is upon this man; Now the prince will be cast out for lying. And still the letter dated 25th June 2019 addressing this fraud stands unrebuted: stands in law.

11. This is not a fight. For we do not wrestle against flesh and blood, but against principalities, against powers, against the rulers of the darkness of this age, against spiritual hosts of

wickedness in the heavenly places (Ephesians 6:12). The defendants were systematically dishonest on eleven occasions in *Your* court on the 21st August 2019. They intentionally entered into a course of conduct which involved deliberate deception, perjury and dishonesty in an attempt to deceive *You* 'the Judge' and Us being 'the True Crown.' The wickedness of these directors: The worries of this life, the deceitfulness of wealth, and the desire for other things, come in and choke the word, and it becomes unfruitful.

12. We are commanded to love the Lord thy God with all thy heart, and with all thy soul, and with all thy mind. This is the first and great commandment. And the second is like unto it, Thou shalt love thy neighbour as thyself. On these two commandments hang all the **law and the prophets**. If you love God, you will obey his greatest of commands and not listen to the evil devilish tongue of any ungodly company.
13. Parramatta City Council has failed to produce proof that they have ceased operation. A recent check of the ABN states that Parramatta City Council is still a private trading company. And no wonder, for Satan himself masquerades as an angel of light.
14. We are aware that the defendants are trying to entrap us in their legal baffle in the email, trying to find a loophole using trickery, knowing they are being deceitful, with every step that they take. Everyone who competes in the games, trains with strict discipline in God's Kingdom: They do it for a 'crown' that is perishable, but *We* do it for a 'Crown' that is imperishable.
15. We are also aware that the defendants will do everything in their power to discredit our divine rights and authority: Our rights to the lands: Our Genealogy which is tattooed on our face: With ochre on our face: the anointed ones by the spirit of God: While standing firmly on the land. No one can tell us who we are based on their deceptive his-story books, for we were formed long ages ago, at the very beginning, when the world came to be, long before mans books were created. So who are they to tell us who we are.
16. No deliverance of an individual can be complete without addressing the issue of foundation. The defendant's foundations are built on fraud, perjury, perverting the course of justice, obstructing the course of justice, failing in their fiduciary duties, professional misconduct, theft, genocide, crimes against mankind and ignorantly performing with a lack of candour. But none is more fragile: when a good foundation has been destroyed, and an evil or weak foundation is built. Here today and gone tomorrow.
17. We herein advise that we do not consent to further submissions being made to the court from the defendant/wrongdoers and their Lawyers (Liars). We do not consent to deceit. We do not consent to fraud in the court. We do not consent to submissions handed to us in court. We do not consent to trickery in emails.
18. We herein advise that we do not agree to any emails, or give consent to the defendants to send any emails to You Judge Gleeson.
19. We herein advise that we are making a formal complaint to the Office of the Legal Services Commissioner, BAR Association against Spark Helmore Lawyers with regards to Perjury: Misprision of Treason in the Court: Fraud in the Court: and Oath of Office for Allegiance.

20. The defendant is not a respecter of the Judge, the courts, the laws, the Prime Ministers or the Originees of this land, as they believe (written in three letters 2014) that they are the superior of us all and the owners of the lands. Even more malice on their behalf is the desecration of burial sites, haughty eyes, a lying tongue, and hands that shed innocent blood, a heart that devises wicked plans, feet that make haste to run to evil, a false witness who breathes out lies, and one who sows discord among brothers.
21. The **Oath of Office for Allegiance to 'The Crown' 'So help me God'**, (King David's Crown) of the covenant to maintain the Laws of God found in the first five books of the King James Bible 1611 from this all man-made legislation is strictly prohibited. This is the Law of Oath to the B.A.R. "British Accreditation Registry" All above must report to the British Monarch (who are Lady Crown's ancestors) who is the Head of the B.A.R. which clearly orders all the above to obey the "Laws of God" This is the Law, and why the King James Bible 1611 is the only instrument at Law for a Court to Sit in competent jurisdiction. Dear Lady Crown,

We refer to proceedings in the Federal Court of Australia with proceedings number NSD711/2019, being LADY CROWN AND OF BEHALF OF NGATI RANGIHOU CORRANGIE HAPU DBA OFFICE OF THE CROWN & ANOR v PARRAMATTA CITY COUNCIL.

Dear Associate,

We refer to proceedings NSD711/2019 which are listed for judgment before her Honour Justice Gleeson on Monday, 14 October 2019. We confirm we act for the City of Parramatta Council. The Plaintiffs are copied into this email and agree to it being sent.

Out of the abundance of caution, and in light of her Honour's impending judgment, we wished to bring to the Court's attention two documents which appear to have been filed by the Plaintiffs on 31 August 2019 and 24 September 2019 respectively. Both documents are titled "Notice of a Constitutional Matter under s78B Judiciary Act 1903". In light of the duty contained in section 78B of the Judiciary Act 1903 should it be the case that a matter arising under the Constitution or involving its interpretation has been so raised, we thought it prudent to ensure these documents had come to her Honour's attention.

Subject to her Honour's views, the parties may seek to make submissions concerning the documents which have been filed and whether the requisite category of matter has arisen.
