I, Lady Crown of PO Box 9144, Harris Park NSW 2150 affirm:

1. i am the creditor and tribal leader of the Ngati Rangihou Corrangie Hapu, the creditors in respect of debt obligation now payable to the sum of *AUD\$495,538,896,968,259.00 (Four Hundred and Ninety Five Trillion, Five Hundred and Thirty Eight Billion, Eight Hundred and Ninety Six Million, Nine Hundred and Sixty Eight Thousand and Two Hundred and Fifty Nine Dollars AUD) owed by CEO Rik Hart and Parramatta City Council, relating to compensation for damages and profiteering from 112 acres, rangihou lands Parramatta, dating back to the gifting of the land in 1811.
2. Description of the debt relied upon initially by Commercial Lien 2013-277-3536-5, AUD\$1,543,653,677,795: Plus outstanding post judgment penalties of AUD\$358,858,257,795: Plus outstanding penalty costs by way of fine AUD\$11,961,269,875: Writ of Enforcement and UCC Filing 201501233073 Commercial Lien 12th January 2016: Notice of Default and Notice of Demand and Declaration Registered Instrument Reference Number 941320524015 12th January 2016: Statutory Demands: 10.3.16, 8.8.16,12.10.16, 12.3.17, 12.4.17 and 12.9.17: plus 25% interest per month since 12th January 2016 AUD Interest and subject to being forced off our rangihou lands on the 21st march 2019.
3. The statutory demand (ninth) dated 1.4.2019 was served via Australia registered post RPP44 63800 09400 08515 89606. It was received by debtor on the 18th April 2019 7.49am. Unrebutted, accepted by equitable estoppels by acquiescence. Attached and marked as annexure h is a copy of the ninth statutory demand 1.4.2019 and receipts of delivery.
4. The statutory demand was sent by our chief advisor Pokapu Pungawerewere (aka Spider Ward) for and on behalf of Office of the Crown who does business for Ngati Rangihou Corrangie Hapu.
5. Parramatta city council has failed to comply with a statutory demand terms and conditions. Ninth statutory is a consolidated total and final obligation which is inclusive of all previous demands dated 10.3.16, 8.8.16,12.10.16, 12.3.17, 12.4.17 and 12.9.17. Unrebutted, accepted by equitable estoppels by acquiescence. Attached and marked as annexure bbbb is the statutory demands.

6. The total obligation debt is still due and payable immediately in full, due to tacit admission, unrebutted, accepted by equitable estoppels by acquiescence at the date that this affidavit is made.
7. A search of the ASIC Published Notices was conducted for court liquidation, creditors voluntary liquidation, deed of company arrangement, deregistration, members voluntary liquidation, scheme of arrangement, voluntary administration and any winding up application. The search results were NO RESULT. Attached and marked as annexure iiiii is the statutory demands.
8. Application is made for a winding up order and liquidation against RIK HART and PARRAMATTA CITY COUNCIL ABN 49907474773, pursuant to section 459G, 459E, 459Q of the *Corporations Act 2001 (Cth)(Act).
9. Application is made to seize company's assets to pay debt and total obligation from RIK HART and PARRAMATTA CITY COUNCIL ABN 49907474773.
10. Application is made to terminate RIK HART and PARRAMATTA CITY COUNCIL ABN 49907474773 by its eventual dissolution.
11. I believe that there is no genuine dispute about the existence or amount of the debt as all statutory demands were unrebutted, accepted by equitable estoppels by acquiescence.
