

Lord's Declaration of Ambassador for Christ

LORD GOD'S EXCLUSIVE DOMINION OVER HIS SAID AMBASSADOR

Greetings in the name (manifesting the presence of) "**Lord**" (the eternal one) thru **Lord-shuah** ("Jesus" for those trusting Lord to save them from sin to righteousness – the eternal one who rescues, delivers, saves and redeems) and thru **Lord's ruach** (the eternal one's essence, breath, wind, presence) in **Lord's Christ** (the eternal one's eternal government whose anointed sovereign and priest is Jesus) manifesting **Lord God** (the eternal one's almighty power of his presence through his righteous people) – **exodus 19:5-6**

In special visitation only – special in-comity foreign-state non-COMMERCIAL ekklesiastical ministerial witness/testimon – without consent to any foreign Venue or Jurisdiction that does not acknowledge the kingdom of Lord and his scriptural right ruling in accord with **romans 13:1-10** which notices us that we are all subject to the highest Lord almighty and our creator's covenant law of scriptural righteousness.

Lord God thru his ekklesia on behalf of his said ambassador declares the following is true, relevant and certain to the knowledge given to his ekklesia so far: whereby **Lord** thru **Jesus & thru yah's ruach of Christ God** – the creator of all's- graciousness, anointing, and appointment, the undersigned: born of water, ruach, and fire from above - **john 3:3,5, matt 3:11** adopted daughter thru Christ Jesus -**gal 4:4-7** bond-servant to Lord's righteousness -**romans 6:18** member of the body of Christ -**1 cor 12:13,27** one of Lord's people -**2 chron. 7:14, Rev 18:4** sister of Jesus -**hebrews -2:10-11** fellow-citizen of the household of Lord -**eph 2:19-22** under Christ Jesus suretiship -**heb 7:22, 24-25** released from Man-Made Schemes -**col 2:13-15** heir of Lord, joint-heir with Christ - **romans 8:16-17** ambassador on behalf of Christ -**2 cor 5:17-21**.

Lord God mandates **repentance** upon which **he remits** (*forgives & pardons*) our sins. Then ruach of Lord abides within each **believing** the **shem-name** of **Jesus Christ** (**luke 24:47, acts 2:38-39, john 14:16-17**) to disciple all nations, immersing those believing in the shem-name of father -**Lord-** & son -**Jesus-** & -**ruach of Lord** unto **obedience** to the mandates of **Christ Lord** -yeshayahu 52:10, matthew 28:18-20;

By God's work of belief in me -**john 6:29** -as Lord's ambassador for Christ, i Crown w/ta Queen Turikatuku III Alexander repent of, * receive remission for, * walk freed from – sins -**romans 8:2** and * am set-apart for righteousness by water, ruach & fire immersion in the shem-name Lord Jesus ruach of Christ God -**john 3:3,5; matt 3:11; 1 cor. 6:11, 2 cor 13:14**. Lord has born me anew from above by-and-with ruach into the kingdom of Lord and into the body of Christ -as an anointed Kingdom Priestess -**exodus 19:5-6; 1 cor. 12:13,27; 1 peter 2:9-10**.

Therefore through Jesus: Christ is in me (**colossians 1:27-29**) and i in Christ (**romans 12:5**) Christ -the government for the Kingdom of Lord- has exclusive preeminence over all things concerning his ekklesia and i -**ephesians 1:19-23**, the exclusive dominion over i is of the ruach of life in Christ Jesus -**romans 8:2**, daughter of the living God – **john 6:68-69**; i was immersed, baptised in sacredness and initiated into all of the above in the shem of Lord yahuwshuach ruach of Christ God **where the seas meet the lands at Rangihou**, kingdom of Lord on the **1st August 2018** when Lord's nature (covenant law) & Jesus's cause character was formally ordained and established for i by Lord for all creation and acknowledged by-and-for all public servants as a 'deed duly registered' on: 1st day of August 2018; autographed with Lord of hosts zeal -**yeshayahu 9:6-7**, Jesus's power –**matt. 28:18**, Christ –**eph. 1:19-23**, and direction of ruach of Lord –**romans 8:4**, as of nunc pro tunc: now 1st day of August scriptural month of year two thousand and eighteen of Jesus Christ's reign.

Note: This "Lord's declaration of ambassadorship" records that the covenant shem-name revealed by Lord for his ambassador for Christ is the only shem-name to be used for her without committing felonies [cf. 18 USC §§ 1001, 1506, 1621, & 2071 (perjuring the public record, etc)] & violating Lord's 3rd mandate – deut. 5:11; keep in mind that Lord is my suretiship – do not touch his anointed – psalms 34:17-22.

Scriptural law* cited in this declaration:

* herein scriptures presented are what referenced scriptural cites mean based upon diligent research in the earliest available original-language, covenant shem, and interlinear scriptures and much ruach of Lord discernment.

exodus 19:5-6 Lord God's desire of the ages: "When we spiritually hear and diligently heed-obey Lord's voice – in ruach-spirit and truth, we thereby live Lord's covenant teaching-way-law, then we are Lord God's treasured possession from among all people – for the earth is mine, says Lord God and we are to him: a... kingdom of priests in the kingdom of yahuah, set-apart to manifest yahuah's righteousness, (and free from false beliefs, idolatry, and sins)." halaluyah! **romans 13:1-10** Let every one be hearing, heeding, and obeying the voice of yahuah and therein doing yahuah's eternal covenant for yahuah's eternal covenant is the only law that applies to all creation, all the time... for there is no power except from yahuah God, and those exercising yahuah's power are established by God. Therefore he who resists yahuah's power is opposed to the way, statutes, mandates, and judgments of God; and those opposed to yahuah receive condemnation upon themselves... **romans 13:1-10** -continued: ... Those exercising Man-Made authority over fellow man are not a cause of fear for those obeying Lord's covenant, but are a cause of fear for those disobeying Lord's covenant.

Do you want to not fear Man-Made authority? Do what is right and good according to Lord's eternal covenant (Lord's 10 mandates -precepts) & Jesus's character (*fruit of ruach-spirit of Jesus*) and you receive praise from Man-Made authority. (*When a man's ways please Lord, he makes even his enemies to be at peace with him -proverbs 16:7.*) For those ministering God's righteousness are for our good. But if we practice evil by doing that which is contrary to Lord's eternal covenant, then we are to be afraid; for Lord God uses the sword of God's ruach through those ministering Lord God's righteous wrath upon those practicing evil.

Wherefore it is necessary to be subject to Lord's eternal covenant, not only to avoid Lord's wrath, but also so that we have a clear conscience before Lord God and all men – whereby we observe Lord's wrath on those disobeying Lord's eternal covenant and we learn to live Lord's eternal covenant by overcoming evil with good.

For because of this we also give to all what is scripturally due to them: for unrighteous rulers are still servants of God giving freedom to those living Lord's eternal covenant and even praising the same, yet punishing those violating Lord's eternal covenant – and to these very things, they are devoted.

Render to all what is scripturally due them: tribute to whom tribute is due (*to those conquering us when we disobey Lord's eternal covenant*); custom to whom custom; respect to whom respect; honor to whom honor.

We are to owe no one anything except to love one another as Lord loves each of us for his purposes – for he who truly loves his neighbor with Lord's love fulfills Lord's eternal covenant law. For, "Do not covet, Do not steal, Do not commit adultery, Do not murder", and if there be any other mandate to us from Lord God concerning our neighbor, it is summed up in, "Love -as Lord loves-our neighbor as ourself" --for love does no wrong to a neighbor; therefore Lord's love thru us manifests us fulfilling Lord's eternal covenant.

john 3:3 *Jesus said to nicodemus*, "Truly truly, I say to you; When anyone is not born from above, he is not able to see the kingdom of Lord."

john 3:5 *yahuwshua*: "Truly, truly I say unto you, unless one be born of water and of ruach, he is not able to enter into the kingdom of Lord."

Whereas Anno Quarto GEORGII IV. REGIS. C A P. XVIII

An Act concerning the Disposition of certain Property of His Majesty, His Heirs and Successors 26th March 1823.

Whereas by an Act passed in the Thirty-ninth and Fortieth Year of the Reign of His late Majesty King George the Third, intituled *An Act concerning the Disposition of certain Real and Personal Property of Her Majesty, and of the Queen Consort for the Time being*, Power was given, or devise, in Manner and Form therein mentioned, all and every or any of the Manors, Messuages, Lands, Tenements, and Hereditaments, purchased or to be purchased by His said then Majesty, His Heirs or Successors, by the Gift or Devise of, or by Descent or otherwise from, any Ancestors or other Person not being King or Queen of this Realm, unto any Person or Persons, for any Estate or Estates, or for any Intents or Purposes, His Majesty, His Heirs or Successors respectively, should think fit; and certain other Provisions were enacted touching and concerning such Manors, Messuages, Lands, Tenements, and Hereditaments; And whereas the Powers and Provisions of the said Act do not extend to Manors, Messuages, Lands, Tenements or Hereditaments, whereof His Majesty, His Heirs or Successors, or any Person or Persons in trust for Him or Them, was, were, or may be seised or possessed at the Time of His or Their Accession to the Crown of this Realm, and which, before such Accession, He or They might have legally granted, sold, given or devised, as He or They respectively might think fit; and it is reasonable that the said Powers and Provisions should be extended thereto:

Be it therefore enacted by the King's most Excellent Majesty, by and with the Advice and Consent of the Lords Spiritual and Temporal, and Commons, in this present Parliament assembled, and by the Authority of the same, That all the Powers given to and vested in His Majesty, His Heirs and Successors, by the said recited Act, over the Manors, Messuages, Lands, Tenements, and Hereditaments purchased or to be purchased by Him or Them, or coming to Him or Them in manner in the said recited Act mentioned, and all other the Provisions of the said recited Act touching and concerning the same. shall be, and the same Powers and Provisions are hereby extended to, and shall be deemed, construed, and taken to extend and apply to all Manors, Messuages, Lands, Tenements and Hereditaments, where to Freehold or Copyhold or Customary or Leasehold Tenure, whereof His Majesty, or any Person or Persona in trust for Him, at the Time of His Accession to the Crown of this Realm, or whereof His heirs or Successors, or any person or Persons in trust for Them, as the Time of their respective Accessions to the Crown of this Realm, was, were, or shall be seised and possessed, and which, before such Accession, He or They respectively might have legally granted, sold, given or delivered.
